- In case of joint holders of any Shares, any one of such joint holders may vote at the Class Meeting of H Shareholders, either personally or by proxy, in respect of such Shares as if he/she is solely entitled thereto. However, if more than one of such joint holders are present at the Class Meeting of H Shareholders, either personally or by proxy, the vote of the joint holder whose name stands first on the register of members in respect of such Shares, whether in person or by proxy, shall be accepted to the exclusion of the votes of other joint holder(s).
- To be valid, this proxy form together with the notarized power of attorney or other authorization document (if any) should be lodged with the Company's H share registrar, Tricor Investor Services Limited, at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong not less than 24 hours before the scheduled time for the holding of the Class Meeting of H Shareholders. Completion and return of a proxy form will not preclude a Shareholder from attending and voting in person at the Class Meeting of H Shareholders or any adjournment thereof if he/she so wishes. In such event, the instrument appointing a proxy shall be deemed to be revoked.
- Shareholders or their proxies attending the Class Meeting of H Shareholders (or any adjournment thereof) shall produce their identity documents. Shareholders or their proxies attending the Class Meeting of H Shareholders shall be responsible for their own travelling and accommodation expenses.
